1. Total program cost is based upon the total number of credits in a degree program, less applicable course material waivers. The total number of credits taken at American InterContinental University may vary due to transfer credits, block transfer, or repeated courses. Students possessing an earned Associate degree from an accredited institution at the time of admission to American InterContinental University may be eligible for a block transfer of credits into select Bachelor degree programs. 2. Program tuition is charged per credit hour each quarter throughout the student's program and is charged at the beginning of each quarter.
3. Course materials are provided to the student by Words of Wisdom, LLC. At the University's discretion, books may be delivered in an electronic (e-Book) or standard textbook format. Students not wishing to use e-Books are responsible for any additional charges associated with purchasing standard textbooks.
4. Course Material charges per term are derived by taking a net average cost of course materials per course multiplied by the number of courses in the term. The average cost of books by degree type are as follows: Undergraduate \$42 per course/Graduate \$35 per course.
5. Course material charges for each term are assessed and billed after the add/drop period of each quarter. Course material waivers for the term (when applicable) will be subsequently applied to student statements during the aforementioned timeframe. Adjustments to book charges will not be made should there be any changes to course schedules after the add/drop period for the term.
6. For all students eligible for the military tuition rate, the course materials charge will be posted to a student's account once each term, after the add drop period. The charge will then be waived, resulting in no net materials cost to the student.
7. Students wishing to enroll under non-degree-seeking status should see the University Course Catalog for applicable information.

Student Tuition Recovery Fund California Residents Only

The State of California created the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic losses suffered by students in educational programs who are California residents, or are enrolled in a residency programs attending certain schools regulated by the Bureau for Private Postsecondary and Vocational Education.

You may be eligible for STRF if you are a California resident or are enrolled in a residency program, prepaid tuition, paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The school closed before the course of instruction was completed.
2. The school's failure to pay refunds or charges on behalf of a student to a third party for license fees or any other purpose, or to provide equipment or materials for which a charge was collected within 180 days before the closure of the school.
3. The school's failure to pay or reimburse loan proceeds under a federally guaranteed student loan program as required by law or to pay or reimburse proceeds received by the school prior to closure in excess of tuition and other costs.
4. There was a material failure to comply with the Act or this Division within 30 days before the school closed or, if the material failure began earlier than 30 days prior to closure, the period determined by the Bureau.
5. An inability after diligent efforts to prosecute, prove, and collect on a judgment against the institution for a violation of the Act.

You must pay the state-imposed assessment for the Student Tuition Recovery Fund (STRF) if all of the following applies to you:

1. You are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition either by cash, guaranteed student loans, or personal loans, and
2. Your total charges are not paid by any third-party payer such as an employer, government program or other payer unless you have a separate agreement to repay the third party.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if either of the following applies:

1. You are not a California resident, or are not enrolled in a residency program, or
2. Your total charges are paid by a third party, such as an employer, government program or other payer, and you have no separate agreement to repay the third party.
