Specialization in **Corrections** and Case Management



AIU[®] offers a professionally-focused BSCJ program with a specialization in Corrections and Case Management, designed so it can offer a deeper understanding of case management services and the complex dynamics of addiction and offender treatment.

CURRICULUM INCLUDES

In this specialized curriculum, students can study the history of criminal punishment, including modern penal systems, prisoners' rights, and factors used to develop personalized sentencing and treatment plans, such as those for prisoners who may have been diagnosed as drug addicts, mentally ill, psychopaths or sociopaths.

Courses are structured to assist students in the development of their goals as they can learn focused knowledge and skills that can be applicable to the fields of Corrections and Case Management. For example:

Penology: students can examine the history of criminal punishment beginning with early developments in Europe, with special attention given to theories of punishment and the development of prisons, correctional institutions and other forms of punishment to the wider system of social control.

Prison Law: students can focus on the historical context in which prisoners' rights were established in the United States and examine landmark court decisions that established these rights and how they changed the administration of corrections.

Offender Rehabilitation: students can study various factors utilized to develop personalized sentencing and treatment plans for individual offenders, including the personality of the offender who may be diagnosed as a psychopath, sociopath, drug addict or mentally-ill person.

- Explain and trace the history and philosophy of adult and juvenile correctional systems and identify the different models of punishment associated with each system
- Explain the history of probation and parole and the roles of the probation and parole officers in the criminal and juvenile correctional systems
- Define community corrections and the innovative approaches associated with this perspective such as restorative justice, peacemaking, intermediate sentences, drug courts and substance abuse counseling
- Apply various assessment, diagnostic techniques and case management strategies for working with adult and juvenile offenders
- Explain the organizational structure, administrative practices and operating procedures of correctional agencies in the handling of personnel and their functions
- Define the development of prisoners' rights, and identify and analyze landmark decisions that substantiate rights for prisoners
- Identify and analyze ethical issues related to decision-making processes associated
 with moral dilemmas in corrections
