## Specialization in Law Enforcement



### OVERVIEW

AIU® offers a professionally-focused BSCJ program with a specialization in Law Enforcement that can provide students with knowledge in police theory, law enforcement practice and organizational management in the field of law enforcement.

### CURRICULUM INCLUDES

In this specialized curriculum, students can study the relationship between police agencies and the communities they serve. Courses are structured to assist students in the development of their goals as they can learn focused knowledge and skills common to a broad range of law enforcement professionals. For example:

**Community Oriented Policing:** students can examine the relationship between police agencies and the communities they serve, including the study of new programs designed to involve the community in resolving crimes, and issues involving police ethics and the public image of police agencies in the media.

**Evidence:** students can explore various types of evidence admissible by law, including real, demonstrative and documentary evidence. The course addresses the roles lay witnesses and expert evidence play in the legal setting, as well as during a criminal trial.

**Crime Mapping and Analysis:** students can be introduced to basic concepts in Geographic Information Systems (GIS) applications in criminal justice, including an overview of how to properly design, construct, manipulate and interpret maps used in policing.

- Define the role of police and their relationship to other components of the criminal justice system including courts, corrections, and forensic science
- Explain the organizational structure, administrative practices and operating procedures of modern police agencies in the handling of personnel and their functions
- Identify specific law enforcement strategies to address substantive problems such as community policing, terrorism and homeland security, cultural diversity, and drugs and crime
- Apply and use critical knowledge of the U.S. Constitution and its practical application to law enforcement and criminal procedure
- Identify and analyze ethical issues related to decision-making processes associated with moral dilemmas in policing
